B. 50/50 Sidewalk Program – Information and discussion

As follow up to the item brought up at the February meeting, Mike Forbes states that he believes that property owners who apply for the program should not have to wait for refunds from the MAD for the 12.5% MAD contribution. He presented one example of a property owner who, in 2003, had to wait 10 months for a refund. Mike believes more property owners would participate if they did not have to wait for the MAD refund. He wants the MAD to recommend to Council District 3 that the Council policy be revised. This item will be brought back for discussion and possible vote at the April meeting. Although Mr. Forbes represents NPCA on the MAD, he indicated that NPCA had taken no position on the issue.

F. Urban Corps expanded services status update – information

Cory provided an update regarding cost clarifications - Urban Corps representatives confirmed cleaning includes graffiti, litter pick-up on side streets, plus one additional person per day (16 hours/week) or 30% increase in labor (2496/year).

Labor is \$22/hour, plus incidental costs (vehicle insurance, supplies, bins and other materials), which average \$30 per week. Current cost is \$39,640/year.

Proposal is \$55,625 per year (effective 13-MAR-10) to expand service to include: Ohio, Illinois, 32nd, Bancroft. Representative offered a graffiti clean-up day at no cost if we agree to new proposal.

An action item to approve increase to operating budget will be added to April Agenda.
