- 3. Chair's Report:

The ongoing project of making the MAD a subcommittee of the NPPC has elicited more questions from the city attorney's office. There is no news on the potential benefit district for the western end of El Cajon Blvd.

- a) Tyler Renner, City Council District 3 office of Councilmember Chris Ward

The proposed Styrofoam (polystyrene) ban goes into effect 30 days after the mayor signs it. No polystyrene products will be permitted to be sold or distributed, and straws will have

to be requested at restaurants. Chris Ward is the chair of the regional task force on homelessness; they need volunteers for the head count. The city received \$14 million in homeless resource funds. There will be a dedicated outreach worker for North Park and University Heights.

The city is going through the budget process. There is a \$73 million deficit. The mayor's State of the City address is tomorrow.

- b) Update North Park Main Street way finding signage Angela Landsberg, Executive Director NPMS

Signs and kiosks will be installed

Angela proposed a monument sign for the median at Alabama and University.

c) Proposed Bikeway - 30th Street between Juniper and Redwood - Matt Stucky

The water pipeline replacement project presents an opportunity to install a bike lane on 30th Street between Juniper and Redwood. Chris Ward's office asked the city traffic engineers to revisit the planned resurfacing to determine the feasibility of a bike lane. There will be a stakeholder meeting in February. Several members of the NPPC want to do outreach. Matt met with Park and Rec management about the Switzer Canyon project envisioned by the MAD. The Switzer Canyon project is not a priority for Park and Rec, so a simple bike lane might be more achievable. Per Peter, the estimated cost of the Switzer Canyon project is \$1.5 million.
